Door Bell Rule Resolution

WHEREAS, pursuant to the Briarwick Condominium Owners Association, Inc. ("Association") By-Laws recorded (as Exhibit "B") under Harris County Clerk's File No. J109905 ("By-Laws"), the Briarwick Condominiums and the business and affairs of the Association, shall be managed and controlled by an elected Board of Directors of the Association ("Board of Directors"); and

WHEREAS, Section 82.102 of the Texas Property Code gives the Board of Directors certain powers, including but not limited to the following powers:

- 1. Regulate the use, maintenance, repair, replacement, modification and appearance of the Condominium; and
- 2. Adopt and amend rules regulating the use, occupancy, leasing or sale, maintenance, repair, modification and appearance of units and common elements, to the extent the regulated actions affect common elements or other units; and
- 3. Exercise any other powers conferred by the Declaration or By-Laws; and
- 4. Exercise any other powers that may be exercised in this State by a corporation of the same type as the Association; and
- 5. Exercise any other powers necessary and proper for the government and operation of the Association; and

WHEREAS, the Declaration of Condominium Regime for Briarwick Condominiums, Phase One, was recorded under Harris County Clerk's File No. J109905 on August 26, 1983 ("Declaration"); and

WHEREAS, pursuant to Section 81.002 of the Texas Property Code and Article I of the Declaration, the condominium "Units" owned by the individual owners refer to the enclosed air space located in a building; and

WHEREAS, pursuant to Section 81.002 of the Texas Property Code and Article I of the Declaration, the "Common Elements" mean the property that is part of the Condominium Regime other than the property that is part of the apartment or the unit; and

WHEREAS, pursuant to Section 3.11 of the Declaration, no owner shall make any alterations or modifications to his unit or to any of the Common Elements without the prior written approval of the Association acting through the Board of Directors based on its authority described above; and

WHEREAS, the Board of Director has considered allowing owners to install doorbells and doorbell cameras on the exterior of their condominium units at Briarwick Condominiums as long as such doorbells comply with the specifications set forth in this Doorbell Rule; and

WHEREAS, on July 16, 2024, the Board of Directors approved a resolution to allow doorbells and doorbell cameras at Briarwick Condominiums as long as such doorbells and doorbell cameras comply with the specifications set forth below.

NOW THEREFORE, it is hereby resolved and this Rule is hereby adopted that owners (and their guests/tenants) are permitted to install doorbells and doorbell cameras at the Briarwick Condominiums as long as such installation complies with the following specifications:

- 1. One doorbell or doorbell camera is permitted to be installed on the front door or the front door frame (i.e., the vertical piece of the door trim located on the right or left side of the front door) of the condominium unit belonging to the owner of the unit.
- Guests and/or tenants of a unit must have the authorization of the unit owner, in writing, prior to the guest and/or tenant installing a doorbell or doorbell camera. Owners are responsible for any violation of this or any other Association governing document.
- 3. The doorbell or doorbell camera is limited in size, to wit: no larger than 6.5 inches long by 2x2 inches wide.
- 4. Installing cameras on the exterior of any unit or on the Common Elements not in accordance with this Rule is a violation of the Association's Declaration.

This Doorbell Rule was unanimously adopted by the Association's Board of Directors on July 16, 2024 and shall be effective when recorded with the Harris County Clerk.
